Columbus Banker attends national meeting for community bank leaders

COLUMBUS – Regulatory relief, BSA/AML compliance and banks' response to cyber threats were just some of the topics discussed at a recent national meeting of community bankers according to Jeff Johnson, President of Columbus Bank and Trust.

Johnson, who attended the meeting as a member of the American Bankers Association's Community Bankers Council May 14-16 in Austin, TX, said the bankers talked about the impact of recent regulatory relief legislation and regulatory requirements on the nation's community banks and the areas they serve.

"Community banks help drive the economy and represent a critical segment of our industry," said Johnson. "This meeting affords us the opportunity to gather information, exchange ideas and develop solutions to the challenges facing our communities every day."

Attendees also discussed a range of topics, including capital leverage ratios, loan growth strategies and political engagement, alongside enhancing the customer experience through technology. The meeting also provided bankers the opportunity to exchange ideas on new products, solutions and management strategies they have implemented recently.

Members meet twice a year to strategize on government relations issues, banking trends and competitive priorities, providing guidance to ABA on a number of community banking issues.
